

Application Privacy Statement

This privacy statement (“Privacy Statement”) applies to the treatment of personally identifiable information submitted by, or otherwise obtained from, you in connection with the associated application (“CeliHack”). The Application is provided by The CeliHack Team. By using or accessing the Application, you acknowledge that you accept the practices and policies outlined in this Privacy Statement.

WHAT PERSONAL INFORMATION DOES CeliHack COLLECT?

We collect the following types of information from our users:

Personal Information You Provide to Us:

We may receive and store any information you submit to the Application (or otherwise authorize us to obtain). The types of personal information collected may include your email address and username necessary for us to provide the Application services.

Personal Information Collected Automatically:

We receive and store certain types of usage related information whenever you interact with the app. Such information may be shared with our partners.

HOW DOES CeliHack USE THE INFORMATION IT COLLECTS?

CeliHack uses the information described in this Privacy Statement (i) internally, to analyze, develop and improve its products and services, and (ii) as set forth below in the “Will CeliHack Share any of the personal information it Collects” section below.

APPLICATION PARTNER TREATMENT OF PERSONAL INFORMATION.

CeliHack may provide personal information to the applicable Application Partner. The Application Partner’s use of your personal information is subject to the Application Partner’s separate privacy policy – and not this Privacy Statement. The Application Partner’s privacy policy can be found in

WILL CeliHack SHARE ANY OF THE PERSONAL INFORMATION IT RECEIVES?

Personal information about our users is an integral part of our business.

Application Partners: We will share your personal information with an applicable Application Partner (see the “Application Partner Treatment” section above).

Agents: We employ other companies and people to perform tasks on our behalf and need to share your information with them to provide products or services to you. You hereby consent to our sharing of personal information for the above purposes. **Business Transfers:** Moreover, if CeliHack, or substantially all of its assets were acquired, or in the unlikely event that CeliHack goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of CeliHack may continue to use your personal information as set forth in this policy.

Protection of CeliHack and Others: We may release personal information when we believe in good faith that release is necessary to comply with the law; enforce or apply our conditions of use and other agreements; or protect the rights, property, or safety of CeliHack, our employees, our users, or others. This includes exchanging information with other companies and organizations for fraud protection and credit risk reduction.

Such third party applications/websites are not under CeliHack's control, and such links do not constitute an endorsement by CeliHack of those other applications/websites or the services offered through them. The privacy and security practices of such third party application/websites linked to the Application are not covered by this Privacy Statement, and CeliHack is not responsible for the privacy or security practices or the content of such websites.

CeliHack allows you to access the following information about you for the purpose of viewing, and in certain situations, updating that information. This list may change in the event the Application changes.
