Client Agreement, Disclaimer & Informed Consent

This agreement establishes the nature, scope, expectations, and boundaries of 1:1 Spiritual Guidance services provided through David Dolce Healing.

Please read this document carefully before participating in a session.

1. NATURE OF SERVICES

David Dolce Healing provides spiritual guidance and personal-growth support intended to encourage reflection, self-awareness, spiritual exploration, personal development, and greater connection with one's own values and sense of purpose.

Depending upon the client's interests and preferences, conversations may include subjects such as:

- Self-love and self-worth
- Personal boundaries
- Forgiveness
- Gratitude
- Spirituality
- Meditation and mindfulness
- Detachment
- Life transitions
- Personal purpose
- Relationships
- Grief and life experiences
- Resilience
- Personal reflection
- Spiritual practices

Participation is voluntary, and clients remain responsible for their own decisions, actions, beliefs, and wellbeing.

2. NOT MENTAL-HEALTH OR MEDICAL TREATMENT

Spiritual Guidance through David Dolce Healing is **not psychotherapy, psychological counseling, mental-health treatment, medical treatment, diagnosis, crisis intervention, or substance-use treatment.**

No diagnosis or treatment of mental-health or medical conditions is provided through this service.

Spiritual Guidance should not be used as a substitute for services from an appropriately licensed physician, psychologist, psychiatrist, therapist, counselor, social worker, or other healthcare professional when such care is needed.

Clients should never discontinue medication, therapy, medical treatment, or other professional care based upon a spiritual-guidance conversation.

When a client's needs appear to extend beyond the scope of spiritual guidance, David Dolce Healing may recommend that the client seek assistance from an appropriately qualified professional.

3. EMERGENCIES AND CRISIS SERVICES

David Dolce Healing does not provide emergency or crisis intervention.

If you believe you may harm yourself or another person, are experiencing a medical or psychiatric emergency, or otherwise require immediate assistance, contact emergency services or an appropriate crisis resource in your location.

Do not rely upon email, social media, text messages, or scheduled David Dolce Healing appointments for emergency assistance.

4. CLIENT RESPONSIBILITY

The client understands that spiritual guidance is collaborative.

The client retains complete responsibility for:

- Personal decisions
- Actions and choices
- Relationships
- Financial decisions
- Medical and mental-health decisions
- Spiritual beliefs and practices
- Implementation of anything discussed during sessions

No particular personal, spiritual, financial, relationship, health, or other outcome is promised or guaranteed.

5. PERSONAL BELIEFS AND SPIRITUALITY

Spirituality is deeply personal.

David Dolce Healing does not require a client to adopt any particular religious, spiritual, philosophical, or metaphysical belief.

Clients are encouraged to question, accept, reject, or modify ideas discussed during sessions according to their own beliefs, judgment, and values.

6. CONFIDENTIALITY AND PRIVACY

David Dolce Healing intends to treat information shared during private sessions respectfully and discreetly.

However, this service is not psychotherapy, legal representation, or another professional relationship that should automatically be assumed to carry legally privileged confidentiality.

Information may also need to be disclosed when required by applicable law, legal process, or circumstances involving safety.

Electronic communications and online sessions also carry inherent privacy and security risks that cannot be completely eliminated.

Clients should participate from a private environment whenever possible.

7. SESSION FEES

Unless otherwise agreed in writing, current standard pricing is:

Initial or Individual 60-Minute Spiritual Guidance Session — \$125

Additional packages or extended sessions may be offered separately.

Prices are subject to change. Any price change will not retroactively alter a session or package that has already been purchased unless agreed upon by both parties.

8. PAYMENT

Payment is required before the scheduled session unless another arrangement has been approved in writing.

A reservation is not considered fully confirmed until required payment has been received.

9. CANCELLATIONS AND RESCHEDULING

Clients are asked to provide at least **24 hours' notice** when canceling or rescheduling an appointment.

Appointments canceled with at least 24 hours' notice may be rescheduled without penalty.

Appointments canceled with less than 24 hours' notice may be charged the full session fee.

Missed appointments without notice are non-refundable.

Exceptions may be considered for genuine emergencies at the discretion of David Dolce Healing.

10. LATE ARRIVALS

Sessions begin and end at the scheduled time.

If a client arrives late, the session may still end at the originally scheduled time to avoid disrupting subsequent appointments.

11. REFUNDS

Completed sessions are non-refundable.

Prepaid packages may be subject to the specific refund and expiration terms presented when the package is purchased.

If David Dolce Healing must cancel an appointment and an acceptable rescheduled time cannot be arranged, payment for the affected session will be refunded.

12. COMMUNICATION BETWEEN SESSIONS

Email, text, website messages, and social-media messages should generally be used for scheduling and administrative matters.

Purchasing a session does not create unlimited access to Anthony David LoDolce between appointments.

Additional spiritual-guidance conversations should normally occur during scheduled sessions.

13. PROFESSIONAL BOUNDARIES

A spiritual-guidance relationship is intended to remain respectful and appropriately bounded.

David Dolce Healing reserves the right to decline, discontinue, or refer services when:

- The client's needs fall outside the scope of spiritual guidance.
- Continuing the relationship would be inappropriate.
- Boundaries are repeatedly violated.
- Safety concerns arise.
- Another professional service would better address the client's needs.

When reasonably possible, clients will be encouraged to seek an appropriate alternative resource.

14. TESTIMONIALS AND PUBLICITY

Participation in spiritual guidance does **not** give David Dolce Healing permission to use a client's name, photograph, story, messages, or testimonial publicly.

Any testimonial, photograph, recording, or identifiable client story used for marketing requires separate permission from the client.

Declining such permission will have no effect on the client's ability to receive services.

15. RECORDING

Neither party should record a private session without the knowledge and express consent of the other party.

16. ACKNOWLEDGMENT AND CONSENT
