

## AFFILIATE PROGRAM TERMS AND CONDITIONS

### 1. GENERAL PROVISIONS

- 1.1. These Affiliate Program Terms and Conditions (hereinafter — the **Terms and Conditions**) determine the procedure of building relations between the Company (hereinafter — the Company) and the Customer who is the Affiliate Program participant (hereinafter — the Partner). The Company and the Partner may be hereinafter jointly referred to as the Parties.
- 1.2. In accordance with these Terms and Conditions, the Partner undertakes on his/her behalf and at his/her own expense to search and attract new Customers, who will open accounts with the Company in order to purchase **Bitbons**.
- 1.3. In its turn, the Company undertakes to pay for the Partner's services on terms specified in these Terms and Conditions.
- 1.4. To register as a Partner, you must register your Bit Trade account on the Company website.
- 1.5. When registering as a Partner, an interested person accepts these Terms and Conditions and confirms that:
  - a) he/she has read these Terms and Conditions;
  - b) he/she fully understands and accepts all provisions of these Terms and Conditions;
  - c) there are no circumstances, which prevent the acceptance of these Terms and Conditions.
- 1.6. The Company provides the registered Partner with a referral link, access to the Company's advertising materials and other affiliate services.
- 1.7. The Company reserves the right to refuse registering the Partner without providing any explanation, including his/her repeated attempts to register in the future.
- 1.8. The Partner unconditionally acknowledges that all the Customers he/she has attracted are the Company's Customers.
- 1.9. The Partner himself/herself as well as persons already registered in the Company (having a Bit Trade account) cannot be the Customer attracted by the Partner.
- 1.10. The Customer cannot be considered as attracted by the Partner if he/she was registered in the Company before the registration date of the account of such a Partner.
- 1.11. The Customer is considered as attracted by the Partner if he/she registers as a Company's Customer for the first time, and he/she visits the Company website using a referral link provided by this Partner.

### 2. RIGHTS AND OBLIGATIONS OF THE PARTNER

- 2.1. The Partner has the right to place referral links to the Company's website on information resources.
- 2.2. The Partner has the right to acquaint potential Customers with the Company's official websites [www.bit.trade](http://www.bit.trade) and [www.bitbon.space](http://www.bitbon.space) and their structure; inform these Customers about the field of activity, services and the Company's competitive advantages.
- 2.3. The Partner has the right to provide comprehensive information support to the Customers who belong to his/her group, independently and in a timely manner inform them about changes in the Company's operation, promotions and other news.



### 3. RIGHTS AND OBLIGATIONS OF THE COMPANY

- 3.1. The Company shall open accounts for the Customers attracted by the Partner on general terms in accordance with “Terms of Use of Bit Trade Services”.
- 3.2. The Company shall record all operations of the Customers attracted by the Partner, and based on these records, pay remuneration and make payments to the Partner in the manner and terms established by these Terms and Conditions.
- 3.3. The Company shall provide comprehensive information support to Partners.
- 3.4. The Company shall timely inform the Partner about important changes in the Company’s operation.
- 3.5. The Company has the right to unilaterally change, rename, add annexes or supplement these Terms and Conditions.
- 3.6. Without any notifications and in any form, the Company has the right to monitor activities of the Partner regarding the performance of his/her functions and duties according to these Terms and Conditions, inter alia, check the Partner’s information resources and methods used for attracting Customers.

### 4. AFFILIATE PROGRAM

- 4.1. To start using the Affiliate Program, the Partner should read provisions of these Terms and Conditions in the “Affiliate Program” section, select the checkbox “I accept the Affiliate Program Terms and Conditions” and click on the “Activate” button.
- 4.2. Once the activation is confirmed, the Partner will be able to select an available tool of online promotion for attracting Customers.
- 4.3. The size of remuneration is the percentage of the **Bitbon** amount purchased by the Customers attracted by the Partner. The Customer must purchase **Bitbons** exclusively through functionality of the «Quick **Bitbon** Purchase Using the Quickbot Service» page. The purchases made in any other way will not be considered when calculating remuneration of the Partner.
- 4.4. In the Bit Trade account, the Partner can check such statistical and financial information as statistics of conducted registrations, sales statistics, request history, and amount of credited remuneration.

### 5. PROCEDURE OF MUTUAL SETTLEMENTS BETWEEN THE PARTIES

- 5.1. The remuneration determined by this section of the Terms and Conditions is the only way to reward the Partner, and the Partner cannot claim other kinds of remuneration.
- 5.2. The amount of remuneration is set at 10% of the **Bitbon** amount purchased by the Customers attracted by the Partner.
- 5.3. The remuneration is credited to the Partner only if the Partner’s ID is specified in the Customer’s account at the moment of transaction execution.
- 5.4. If during registration or at the moment of transaction execution the Customer has not specified the Partner’s ID (intentionally or unintentionally), the Partner does not receive remuneration for such a transaction.



## 6. OTHER CONDITIONS

- 6.1. To develop partnership with the Company, the Partner has the right to request additional information for further use by contacting the Company's Customer Support.
- 6.2. The Company has the right to unilaterally decide whether or not to provide the requested information.
- 6.3. The Company has the right to unilaterally and without any prior notice delete or terminate the provision of any materials to the particular web resource if this web resource, or the context in which the materials are used, is deemed inappropriate. If such situations arise and in order to prevent any recurrence in future, the Company shall apply sanctions considered sufficient, at its sole discretion, against the Partner (including fines).
- 6.4. The Company and the Partner shall be exempted from responsibility for partial or complete non-fulfillment of their obligations hereunder, if such non-fulfillment occurred as a result of circumstances beyond control of the Parties (force majeure). Such circumstances may include floods, earthquakes, other natural disasters or any natural phenomena, epidemics, terrorist acts, military actions that make fulfillment of the obligations assumed impossible.
- 6.5. PLEASE NOTE! By accepting these Terms and Conditions, the Partner agrees that the Company does not credit or compensate percentage remuneration according to the trading results of the Customer he/she attracted if, at the time of purchasing **Bitbons**, the Customer has not been recorded in the system for this Partner by his/her referral number.
- 6.6. If, at the time of purchasing **Bitbons**, the Customer attracted by the Partner is not assigned to the Partner in the system based on his/her referral number or if, when registering his/her Bit Trade account, the Customer has specified a Partner's ID that is different from that of the Partner who has attracted him/her, then the Company shall bear no responsibility and cannot guarantee remuneration accrual to the Partner.
- 6.7. The Company uses cookies on its website. The Company does link the information it stores in cookies to any personally identifiable information that the Customer submits when using its website.
- 6.8. The Company shall not be liable for misuse or loss of personal information as a result of cookies on its website which the Company does not have access to or control over.

## 7. RESTRICTION IMPLIED DURING ATTRACTION OF CUSTOMERS

- 7.1. The Customers in the status of a Partner are prohibited to:
  - use the Company's tools on websites that host obscenities, information on drugs, alcohol and tobacco products, pornographic, erotic or other sexually explicit content, which is not part of the work of art, materials that promote terrorism.
  - use services of automated promotion (automation of visits, surfing), services on tasks implementation (paid execution of registrations, leads).
  - use the Company's tools on websites that contain malicious code.
  - use advertising in the form of spam to attract Customers through Email, mobile messengers (Viber, Telegram, WhatsApp etc.) in social networks and other resources.
  - create websites, the external view of which has similarities to the official website of the Company (e.g. creation of website copies with HTML iframe tag).

- use the Company's tools on websites that use "black" methods of search engine optimization (cloaking, doorway pages etc.).
  - use the Company's tools on websites where more than three pop-up windows or advertisements take more than 50% of the total content.
- 7.2.** Violations of these Terms and Conditions, and in particular Clause 7.1., may result in blocking of the Partner's Bit Trade account that cannot be recovered.
- 7.3.** The Company reserves the right to block tools of online promotion provided to the Partner for attracting Customers if the Company discovers that the Partner distributes information, which is characterized by a high degree of distortion of the original meaning compared with the original content posted on the website [www.bitbon.space](http://www.bitbon.space).
