We produce premium machinery and consumables that are used to make dental prosthetics. With our innovative and high-quality products, we want to improve the oral and dental health and well-being of people all around the world.

Environmental and Social responsibility, and good Governance (ESG) each represent essential aspects of good business conduct. Sustainability in itself is to our understanding the potential to produce and consume within the regenerative capacity of the earth. Amann Girrbach aims to minimize the company car and business travel footprint through implementing a range on measures including acquisition of electric or hybrid cars for the company fleet, investing in video conferencing equipment and facilitating working from home

Amann Girrbach is committed to shift towards a sustainable, low energy-intensive and low-carbon economy by extending the lifetime of our products, improving the efficient use of materials and allowing for refurbished CAD/CAM products where possible and recycling/reusing (packaging) materials.

Amann Girrbach is committed to reduce its environmental impact through environmentally conscious management of its sites, by means of ecologically optimized purchase, production and distribution processes and including energy efficiency and renewable energy.

Social

Amann Girrbach values its employees' health and safety, as well as the health and safety in the extended value chain.

Amann Girrbach continues to ensure high levels of product quality & safety. The quality management system is certified according to ISO 9001 and ISO 13485.

Prosthetic production machinery will be further digitalized, thereby creating high-speed and fully automated processes. Amann Girrbach is committed to improve machinery and automated processes and to maximize access to cost effective high-end dental prosthetics for patients.

Amann Girrbach is committed to act in accordance with internationally recognised human rights. Amann Girrbach supports the abolition of child labour and other forms of forced labour and actively works to prevent this at business partners' operations as well.
