## d.velop documents

### 1 Overview

In addition to the "d.velop cloud platform service description", the product-specific functionalities of d.velop documents are described herein.

The services support, availability and update of d.velop documents are described in the "Service Level Agreement Cloud & SaaS".

### 2 Scope of d.velop documents

With d.velop documents, you may intelligently accelerate, simplify and optimize the administration of documents and information. d.velop documents provides a smart filing system for quick and easy document retrieval. With this cloud solution you focus on comprehensive collaboration and digital business processes that are optimally supporting your work. Covering the entire process cycle, your documents are always securely archived.

In case of termination of the contract, the customer will have his documents in the same (original) format in which they were saved (Tiff, JPG, docx, PDF etc.) as well as a file in "JSON" format containing all attribute information for the respective file.

d.velop documents „free for 30 days“

By booking d.velop documents – “free for 30 days” you get the fully-featured d.velop documents (comparable to d.velop documents ultimate) free for 30 days. After expiration of a 30 days period you decide for one of the d.velop documents editions (basic, business, ultimate). The 30 days free trial period ends automatically when you do nothing and all your documents and data are deleted after a period of 30 days. However, if you decide to continue using documents within this period, all your documents and data are restored and you may continue your work where you left it.

The following overview shows the scope of the three editions “documents basic”, “documents business” and “documents ultimate”.

You have the option to object at any time to our using your imported documents to improve our deep learning methods. In this case, the service will not make any adjustments to the contents you process. This may reduce the recognition success rate. This does not constitute a material defect.
- <sup>2)</sup> Cloud storage is declared per tenant, i. e. per document repository. Storage space can be flexibly extended for 0,19 € / GB and month. Billing takes place on a monthly and usage-bound basis.
- <sup>3)</sup> The following file formats are automatically being converted to PDF: doc, docx, dot, dotx, xls, xlsx, xlsb, ppt, pptx, pot, potx, jpeg, tif, bmp, gif, png, pdf, txt, msg, eml, zip, rar, dgix, dgia, dgim
- <sup>4)</sup> Simple workflows are workflows that have been created with the integrated workflow and forms editor of d.velop documents and that consist of a linear sequence of activities.
- <sup>5)</sup> The customer is liable to pay for using the open REST-API in the context of connecting portal solutions with d.velop documents. Prices result from the d.velop documents pricing model.
