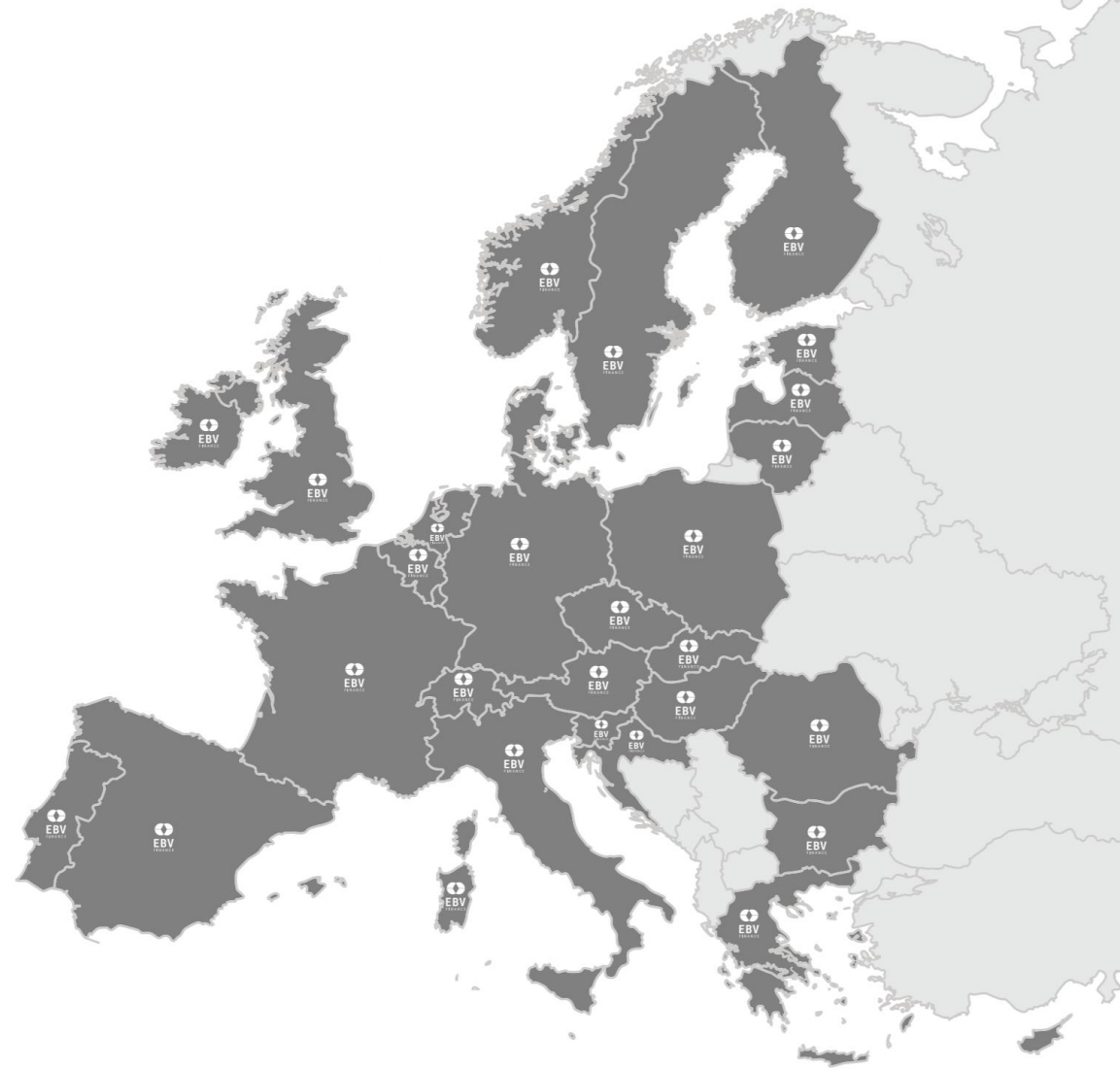

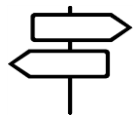
Leading in the Baltics and rapidly growing company, specializing in financing and refunding of VAT and Excise duties.

Fast VAT refund when money is transferred to the client's account within 2 business days for the VAT of the whole quarter.

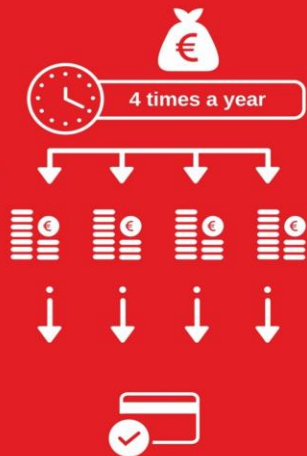

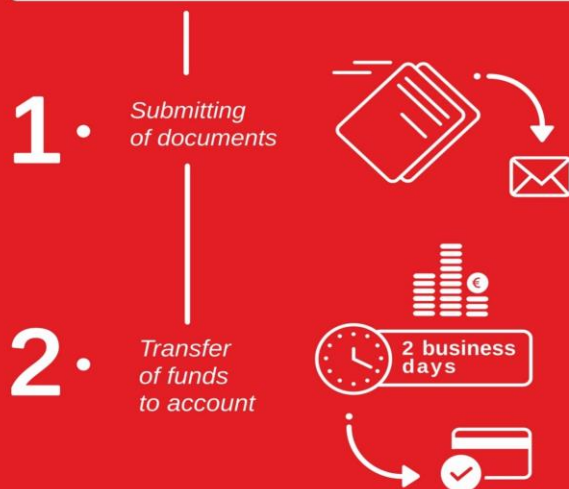




## Products at glance (3)

### FAST EXCISE CASH

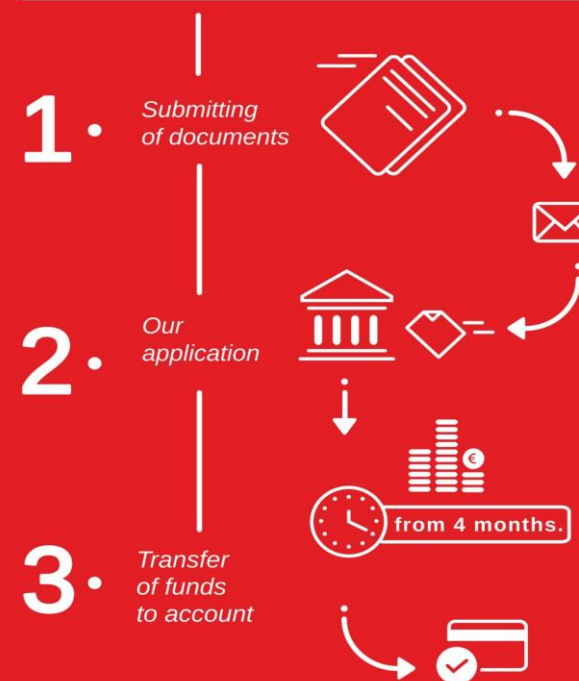
Money is paid for the refundable excise duty within 2 business days, without having to wait for the usual reimbursement period.



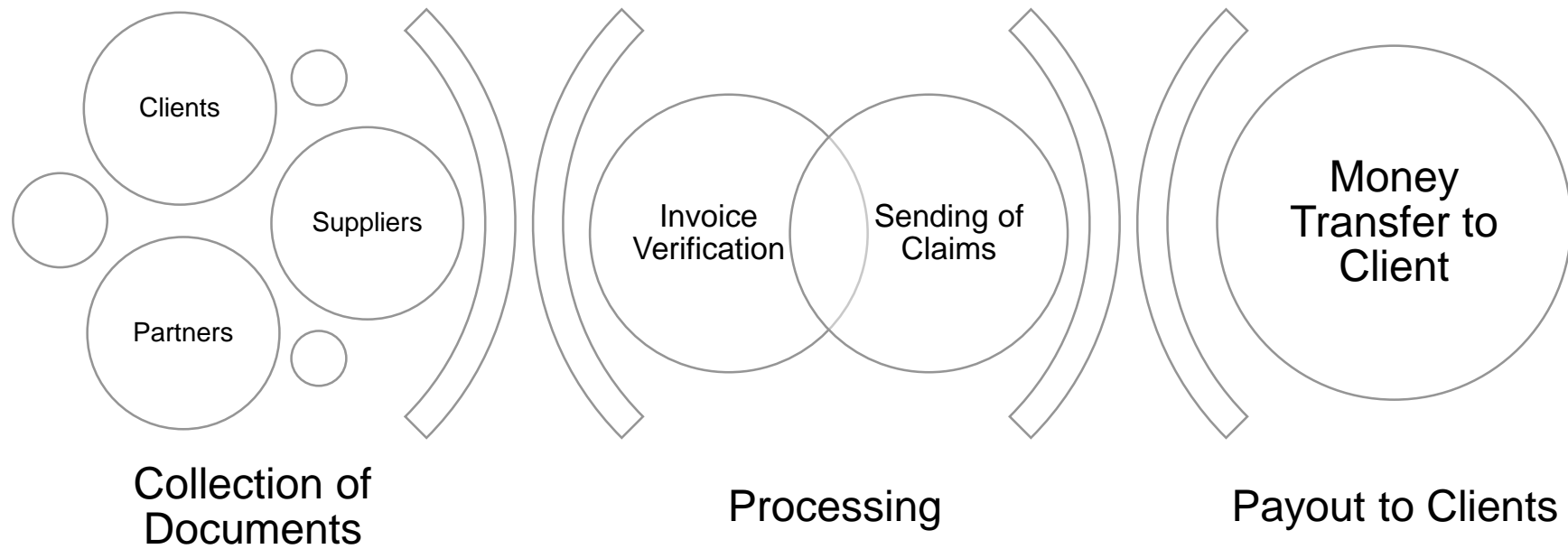
- This service is available only:

### STANDARD EXCISE REFUND

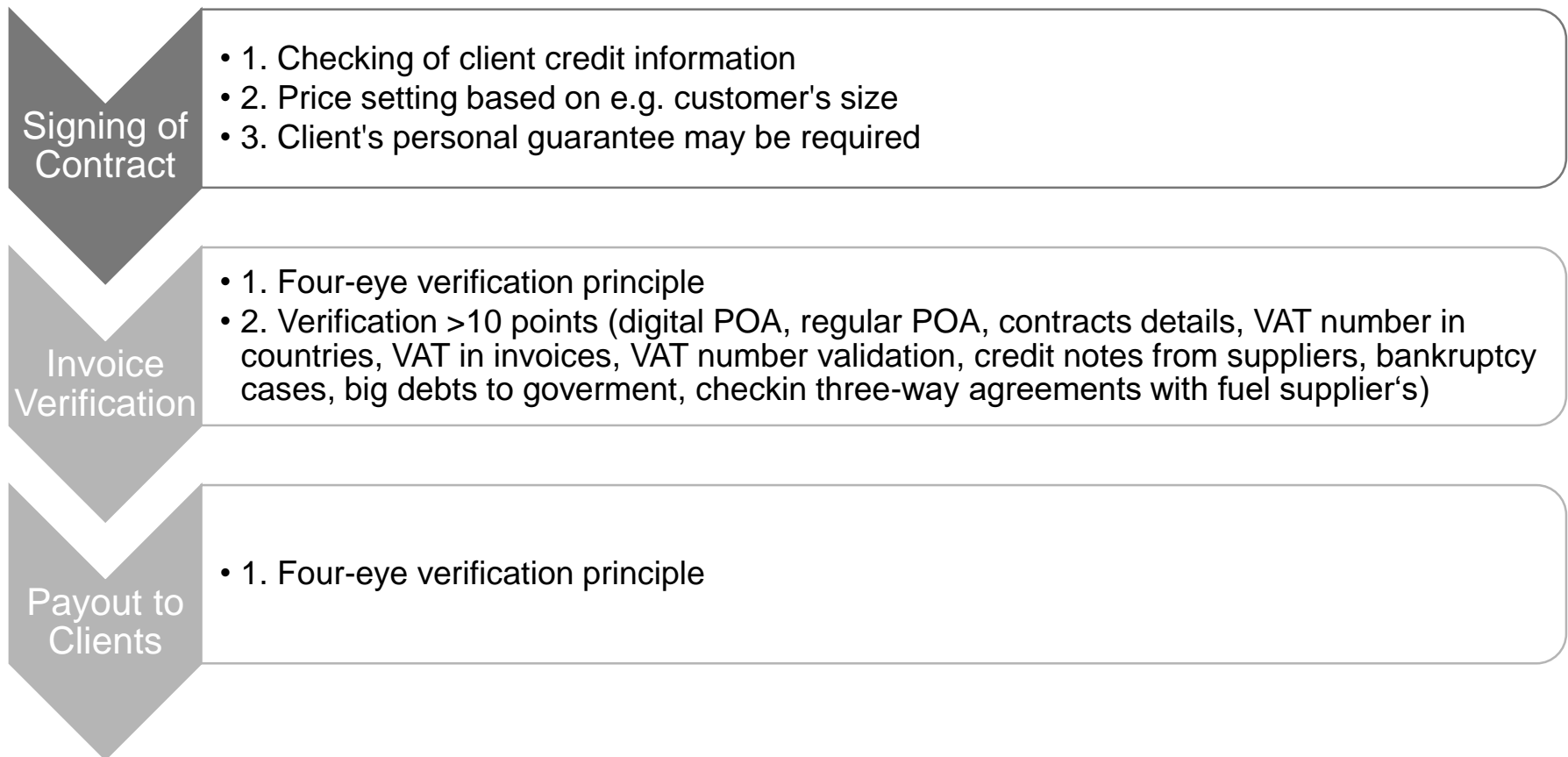
Standard excise duty refund within usual period.



## VAT Recovery Process

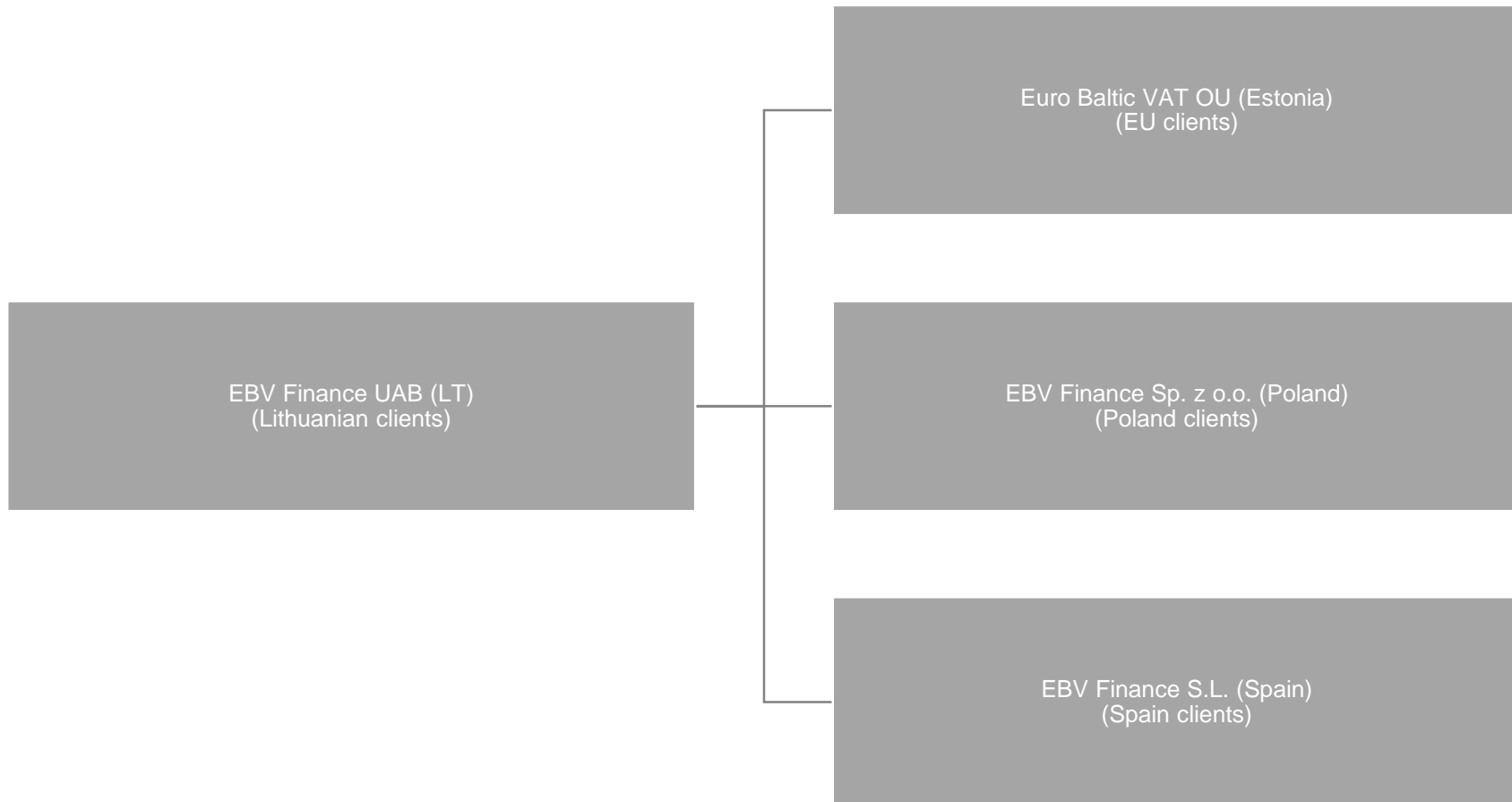
