## **Fireof Cashback Campaign Terms and Conditions**

1. Terms that are capitalized in the present Terms and Conditions of the Campaign have the same meaning as the terms used in the [General Terms and Conditions of the Portal User Agreement](#) unless otherwise indicated in the present Terms and Conditions of the Campaign.
2. The Fireof Cashback Campaign (hereinafter – Campaign) is valid from February 14, 2019 to March 14, 2019 (23:59:59 GMT2+).
3. During the time frame indicated in Clause 2, any User has the right to participate in the Campaign.
4. Participation in the Campaign grants the User a right to receive a cashback bonus for investments made on the Primary Market in Fireof loans with a maturity of 10 months or more.
5. To participate in the Campaign the User has to enroll in the Campaign on the Campaign page (<https://www.mintos.com/en/campaigns/>). After enrolling the User will see a confirmation message about being successfully enrolled in the Campaign.
6. Cashback is calculated for any new investments made on the Primary Market (both manually and via Auto Invest) in Fireof loans with a maturity of 10 months and longer:
  - 6.1. 1.0% for investing EUR 100 up to EUR 499 in FIREOF loans;
  - 6.2. 1.5% for investing EUR 500 up to EUR 999 in FIREOF loans;
  - 6.3. 2.0% for investing more than EUR 1 000 in FIREOF loans;
7. The User would receive the cashback at the end of the campaign based on the total amount invested over the duration of the Campaign stated in Clause 2.
8. Cashback is not calculated for:
  - 8.1. investments made on the Secondary Market;
  - 8.2. investments made prior to enrolling in the Campaign as stated in Clause 5;
  - 8.3. users who have not enrolled in the Campaign as stated in Clause 5.
9. The cashback is paid in one installment within 6 (six) working days from the end date of the cashback campaign based on the accumulated amount invested, if all terms and conditions set out in this document have been fulfilled.
10. The cashback is paid by Fireof based on the calculation provided by Mintos. Mintos acts as an intermediary and pays the User on behalf of Fireof by depositing electronic funds equivalent to the cashback into the Virtual Account of the User.

12. The User has an obligation to immediately stop his/her participation in the Campaign if requested by Mintos in case of suspicion of fraud.

13. Legal relations arising from the Campaign shall be governed by the Terms and Conditions of the Campaign that were published on the Portal at the moment when the User enrolled in the Campaign as stated in Clause 5.

14. Mintos has the right to end or change the present Terms and Conditions of the Campaign unilaterally and without individually notifying the User.
