

§ 1. GENERAL CONDITIONS OF USE OF THE PROMOTIONAL OFFER

1. The Promoter of the „Data package in EU roaming” offer is VikingCo Poland sp. z o.o. with its registered office and address in: ul Tęczowa 13/210, 53-601 Wrocław, entered into the Register of Entrepreneurs of the National Court Register, KRS registration number 0000484436, kept by the District Court for Wrocław Fabryczna, 6th Commercial Division of the National Court Register, NIP [tax identification number] 8971793639 and REGON [national business registry number 022284492 hereinafter referred to as Provider.
2. „Data package in EU roaming” promotional offer (hereinafter referred to as Offer) is aimed at both new and present Users of the ‘Minutes+SMS+Internet’ tariff provided by Mobile Vikings Network.

§ 2. SUBJECT AND MATTER OF PROMOTION

3. For the specific price for the Service the Users are given a data package to use on data transmission in following countries: Austria, Azores, Belgium, Bulgaria, Canary Islands, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, French Guyana, Germany, Gibraltar, Greece, Gwadelupe, Hungary, Iceland, Ireland, Italy, Liechtenstein, Lithuania, Luxembourg, Latvia, Madeira, Malta, Martinique, Netherlands Norway, Portugal, Reunion, Romania, Slovakia, Slovenia, Spain, Sweden, United Kingdom, Vatican City.
4. Data package size and costs go as follows in Table nr 1:

5. Data transfer within the package is settled every 1kB. Data units are subtracted from the account with every new 1kB transmission started.
6. Data package in EU roaming is valid for 30 days after activation. After that period it is to be deactivated with unused data not being available anymore. The data package value and its costs are not refundable.
7. The User may activate any number of Data packages in EU roaming of any size. Every activation extends the validity period of the Service by 30 days.
8. In case of full data consumption of the data from the package before the end of 30 days validity period:
 - a further use of the Internet will be charged 4gr / 1MB according to Mobile Vikings Price List,
 - b Or the User can activate another Data package in EU roaming.
9. The Provider do not impose any limit of maximum MB amount collected by the User on the account balance for given number within the Provider's Network.
10. The conditions of use of the Offer are:
 - a) To have an Internet User Account on www.mobilevikings.pl webpage
 - b) To have an active SIM card in 'Minutes+SMS+Internet' tariff
 - c) To have enough credit (in PLN) on account balance to cover activation charges of chosen Package in the moment of submitting the order.
11. To use the Offer User needs to:
 - a) After logging in to Internet User Account on www.mobilevikings.pl webpage or using Mobile App, choose the promotional package
 - b) Buy the package using credit from the Top-Up available on the User's Account Balance.
12. Package activation is performed within 24 hours from the moment of completing the conditions stated in the point above.
13. Package activation is possible under the condition of having enough credit on the Account.
14. The User can check if the „Data package in EU roaming” Service is active by logging in to the Viking Account on www.mobilevikings.pl webpage.
15. Used MB balance can be checked by entering and confirming the short USSD code *575# on the phone keyboard. The code may not be supported by some foreign Network Providers (in this case it is suggested to contact Help Desk – charges for the call are settled according to international roaming price in Mobile Vikings Price Plan). Information provided by using the USSD code may be incorrect due to service of foreign Network Providers. Mobile Vikings has no effect on these errors.
16. The Package can be used for data transmission using APN Internet configuration.

§ 3. ADDITIONAL INFORMATIONS

17. Using the Service do no limit any other Services and Promotional Offers as long as the regulations of these Services and Promotional Offers do not state otherwise.
18. Using the Service is possible under the condition of having the service of International Roaming active.
19. All the words and phrases written in this document with capital letters and not explicitly defined are to be understood according to the definitions stated in the Regulations for the Telecommunications Services provision by VikingCo Poland and Mobile Vikings Price Plan.

20. In the scope not regulated in this document the Regulations for the Telecommunications Services provision by VikingCo Poland and Mobile Vikings Price Plan will have an effect.
21. In case of discrepancies between the statements of this documents and the documents stated above, statements present in this regulations will be superior.
22. The Provider reserves the right to cancel this document and to stop providing the Service with no need to state the reasons to do so, with the User keeping the rights and obligations obtained before.

24. All the prices stated in this document are given in polish złoty (zł) and include Value Added Tax (VAT) unless it is not stated otherwise.
