

## § 1. GENERAL CONDITIONS OF THE USE OF PROMOTIONAL OFFER

1. The Promoter of the „ Viking No Limit” Promotional Offer (hereinafter referred to as the „Promotional Offer”) is VikingCo Poland sp. z o.o. with its registered office and address in Wrocław (ul. Tęczowa 13/210, 53-601 Wrocław), entered into the Register of the Entrepreneurs of the National Court Register, KRS registration number 0000484436, kept by the District Court for Wrocław Fabryczna, 6th Commercial Division of the National Court Register, NIP [tax identification number] 8971793639 and REGON [national business registry number] 022284492, share capital: PLN 11,244,200 fully paid up – hereinafter referred to as the „Operator” or „Mobile Vikings Poland”.
2. This Promotional “Viking No limit” Offer is addressed to all Users using “Minutes+SMS+Internet” tariff of Mobile Vikings.

## § 2. SUBJECT- MATTER OF THE PROMOTION

3. Follow the instructions described in the following Sections to benefit from the Promotion.
4. Using the Promotion constitutes acceptance of these Regulations.
5. Details of the Promotional Offer:

6. The conditions for activating the Promotional Offer include:
  - a) having the Internet User Account at [www.mobilevikings.pl](http://www.mobilevikings.pl) or through an app
  - b) having an active SIM Card at “Minutes+SMS+Internet” tariff
  - c) having available credits on the User account, in the amount of the fee for the preferred Promotional Offers option at the time of activation, and having the outgoing calls validity Period.
7. Follow the instructions described in the following Sections to benefit from the Promotional Offer.
  - a) log into the Internet User Account at the following website [www.mobilevikings.pl](http://www.mobilevikings.pl)
  - b) select the chosen option of the Promotional Offer
  - c) make payment for the chosen option of the Promotional Offer by selecting one of the available payment methods.
8. Repeat the procedure as described in Section 7, to re-activate the Promotional Offer.
9. A person who wants to benefit from the Promotional Offer, and has not yet used the Mobile Vikings services, should purchase a new SIM card, or transfer his/her previous phone number to Mobile Vikings by following the below steps:
  - a) go to [www.mobilevikings.pl](http://www.mobilevikings.pl)
  - b) select the Promotional Offer
  - c) enter data and address for shipping the card
  - d) make a payment
  - e) after activation of the card or on the day of transferring the previous phone number the User must have on his/her account credits available in the amount of the fee for the chosen Promotional Offer at the time of its activation, and the outgoing calls validity Period
10. Price of the Promotional Offer option is an activation fee and is not synonymous with making the Top-Up.
11. The User shall be provided with the possibility to use the Promotional Offer within 24 hours of the performance of the activities referred to in Sections 7 or 9 hereof. Provision of the services shall begin when activating the Promotional Offer.
12. In the Viking 25 No Limit Promotional Offer, the User shall be notified by SMS about the activation of the unlimited calls package. Making calls to landlines or mobiles before receiving SMS messages will result in debiting the User’s available credits in accordance with the Price List
13. In the Viking 39 No Limit Promotional Offer, the User shall be informed about the activation of the unlimited calls package and the additional 10 GB mobile data package, via SMS. Making calls to landline or mobile phones before receiving the SMS, will result in charging credit from the user’s balance according to the Price List, which can lead to the lack of activation of the unlimited calls to all mobile and landline numbers package and the additional 10 GB of mobile data package.
14. One Promotional Offer can be activated at one time in the manner indicated Section 10.
15. The periods of validity of unlimited calls do not cumulate in case of buying several Promotional Offers.
16. However, within the Promotional Offer, the User can buy any number of one or two options of the Top-Ups.
17. The Promotional Offer activation causes extension of the outgoing calls validity Period by 365 days.

18. If the Promotional Offer is purchased while having an active Play Viking Package (unlimited calls to Mobile Vikings and Play), the validity of the unlimited calls to mobiles and/or landlines will still cover 31 days from the date of activation.
19. Activating the Promotional Offer while having another active offer, at the same time, will cause cumulating of the unused Internet package in the User's account and extend his/her period of validity by 31 days from the date of activation of the Promotion.
20. The unlimited calls to mobiles and/or landlines can be made during 31 days from the date of activation of the Promotional Offer. After this period, the fee for calls shall be calculated in accordance with the Price List of "Minutes+SMS+Internet" tariff.
21. After expiry of the validity period for the packages indicated in Table 1. the fees for calls, SMS and the Internet shall be charged according to the Price List.
22. Deactivation of the Package during its term of validity is not possible.
23. Repeat after 31 days the procedure described in Section 7 of this Promotional Offer to re-activate the Promotional Offer.
24. The Promotional Offer status can be checked on the Online User Account, under "My card".
25. Using the packages is only possible within the Republic of Poland using the Internet APN settings of the Operator. The Promotion is not active within the international roaming.

### § 3. ADDITIONAL INFORMATION

26. All prices indicated in these Regulations are in Polish zloty (PLN) and include VAT, unless otherwise specified.
27. Under this Promotional Offer the User shall:
  - a) not direct traffic from other telecommunication networks without the consent of the Telecommunications Network Operator or networks of other telecommunications companies by means of any telecommunication devices using the SIM/USIM Cards received by the User
  - b) not direct traffic from other telecommunication networks without the consent of the Telecommunications Network Operator or networks of other telecommunications companies by means of any telecommunication devices using the SIM/USIM Cards received by the User
  - c) not generate artificial traffic for the exchange of information
  - d) not use SIM/USIM card for telemetry
  - e) not use the SIM/USIM Card for the traffic generated by machine, in particular "machine-to-machine" and "machine-to-user" traffic type
  - f) not use the SIM Card to generate traffic, which is a Denial of Service attack
  - g) not use the SIM/USIM Cards without Operator consent, to initiate the traffic/ involving the mass calls making, particularly in the case of automatic calls distribution or automatic interactive called number service, or in the case of telecommunication and information systems integration for this type of traffic or when using the cards in direct marketing (the prohibition applies to the User acting as an entrepreneur or on behalf of another entrepreneur)
  - h) not use the SIM/USIM Card for the mass mailing of information (SMS or MMS) intended directly or indirectly to promote goods, services or image of the User or another entity, or in some other way of achieving any commercial effects (the prohibition applies to the User acting as an entrepreneur or on behalf of another entrepreneur).
28. In the event of a breach of the provisions laid down in Section 27 points a. to h. of this Promotional Offer by the User, the Operator may suspend the provision of Services.

29. As a part of this Promotional Offer, the Subscriber is obliged to adhere to the Regulations for the Telecommunications Services provision.
30. In the event of the violation of these regulations or the Regulations for the Telecommunications Services provision, the Operator may suspend the provision of the Services.
31. Using of this Promotional Offer does not exclude the possibility of using other Promotional Offers offered by the Operator, as long as the Regulations of these Offers do not provide otherwise.
32. To all matters not settled in these Regulations, the provisions of the Mobile Vikings Poland Price List and the Regulations for the Telecommunications Services provision, shall apply. In the event of discrepancies between the provisions of these regulations and the aforementioned documents, provisions of this Promotional Offer will have precedence.
33. The definitions used in this Offer (specifically those written with capital letters) are to be understood according to the definitions included in the Price List or the Regulations for the Telecommunications Services provision.
34. Regulations for the Telecommunications Services provision, Price List as well as the remaining documents regulating the provision of the services by the Operator are published and made available on the website of the Operator at: [www.mobilevikings.pl](http://www.mobilevikings.pl)

The Operator reserves the right to alter the contents of these Regulations or to recall it at any time without giving a reason, with the reservation, that the change or the recall of the terms and conditions does not affect the rights and responsibilities obtained by the Subscriber.
