

§ 1. PRELIMINARY PROVISIONS

1. The Promoter of the „I have more” Promotional Offer (hereinafter referred to as the „Promotional Offer”) is VikingCo Poland sp. z o.o. with its registered office and address in Wrocław (ul. Tęczowa 13/210, 53-601 Wrocław), entered into the Register of the Entrepreneurs of the National Court Register, KRS registration number 0000484436, kept by the District Court for Wrocław Fabryczna, 6th Commercial Division of the National Court Register, NIP [tax identification number] 8971793639 and REGON [national business registry number] 022284492, share capital: PLN 11,244,200 fully paid up – hereinafter referred to as the „Operator” or „Mobile Vikings Poland”.
2. This Promotional Offer is aimed at the Subscribers of Mobile Vikings Poland, who are using the „Minutes+SMS+Internet” offer and the Auto top-up function for a minimum of 19 PLN for one or more active telephone numbers on a single User’s Internet account..
3. Using this Promotional Offer means the acceptance of the contents of these regulations.

§ 2. SUBJECT-MATTER OF THE PROMOTIONAL OFFER

4. As a part of the Promotional Offer, the Subscribers fulfilling the condition defined in § 1 point 2 of these regulations, as a part of a renewed package, shall receive an additional GB of mobile data (hereinafter referred to as the „Promotional Package”) for each number, which has been topped-up with the Auto top-up function, depending on the amount of owned, on the User’s Internet account, telephone numbers according to the table below:

1	1 GB	31 days
2	2 GB	31 days
3 and more	3 GB	31 days

5. Verification if the condition, from point 2, has been fulfilled takes place on each first day of the month. The Promotional Package will be granted on the first day of the month, by the end of the day at the latest, providing that the condition from point 2 has been fulfilled within the last 31 days, preceding the verification.
6. If the Auto top-up will be deactivated during the calendar month, however there was a top-up with the use of this function within the verified period, the condition from point 2 will be deemed as fulfilled, and the Promotional Package shall be granted according to Table no. 1.
7. The Promotional Package of mobile data will accumulate with the amount of data available at the current moment on the Subscriber's balance, and its validity period will amount to 31 days, counting from the day of the activation of the Promotional Package.
8. The amount and the validity of the Internet package can be checked each time after logging into the Subscriber's Internet account at www.mobilevikings.pl/pl/mysims/, on the Mobile Application shared by the Operator, or by inputing a short USSD code - *108# on your phone.
9. The activation of the Package does not extend the Validity period of outgoing calls, bonus SMS/MMS package or unlimited calls.
10. The Subscriber cannot commission the deactivation of the granted Promotional Package of mobile data, or to pass it, to be activated, on another number within the Subscriber's Internet account.
11. The Promotional Package will be automatically deactivate upon the end of its validity period, in case it is not renewed by the purchase of a new Top-up or the purchase of an additional mobile data package.

12. The description of the Auto top-up service is defined in the „Brief description of the Auto top-up service” and „Conditions of using tools initiating a top-up”, which are published and shared on the Operator’s website.
13. The use of the Promotional Package is possible only within the territory of the Republic of Poland with the use of the APN Internet settings of the Operator. The promotion is not active in international roaming.

§ 3. FINAL PROVISIONS

14. As a part of this Promotional Offer, the Subscriber is obliged to adhere to the Regulations for the Telecommunications Services provision.
15. In the event of the violation of these regulations or the Regulations for the Telecommunications Services provision, the Operator may suspend the provision of the Services.
16. Using of this Promotional Offer does not exclude the possibility of using other Promotional Offers offered by the Operator, as long as the Regulations of these Offers do not provide otherwise.
17. To all matters not settled in these Regulations, the provisions of the Mobile Vikings Poland Price List and the Regulations for the Telecommunications Services provision, shall apply. In the event of discrepancies between the provisions of these regulations and the aforementioned documents, provisions of this Promotional Offer will have precedence.
18. The definitions used in this Offer (specifically those written with capital letters) are to be understood according to the definitions included in the Price List or the Regulations for the Telecommunications Services provision.
19. Regulations for the Telecommunications Services provision, Price List as well as the remaining documents regulating the provision of the services by the Operator are published and made available on the website of the Operator at: www.mobilevikings.pl

The Operator reserves the right to alter the contents of these Regulations or to recall it at any time without giving a reason, with the reservation, that the change or the recall of the terms and conditions does not affect the rights and responsibilities obtained by the Subscriber.
