

## § 1. GENERAL CONDITIONS OF USE OF THE PROMOTIONAL OFFER

1. The Organiser of the „Viking Net” Promotional Offer is VikingCo Poland sp. z o.o. with its registered office and address at: ul. Tęczowa 13/210, 53-601 Wrocław, entered in into the Register of Entrepreneurs of the National Court Register, KRS registration number 0000484436, kept by the District Court for Wrocław Fabryczna, 6th Commercial Division of the National Court Register, NIP [tax identification number] 8971793639 and REGON [national business registry number] 022284492, hereinafter referred to as the Operator.
2. This Promotional "Viking Net" and „Viking Net&Night” Offer (hereinafter referred to as the „Promotional Offer”) is addressed to both new and current Subscribers, that use the „Mobile Internet” tariff from Mobile Vikings.

## § 2. SUBJECT MATTER OF THE PROMOTIONAL OFFER

3. Subscribers mentioned in §1, as a part of the service, may use the data transfer, via P4 Telecommunications Network, within the territory of the Republic of Poland.
4. Follow the instructions described in the following points to benefit from the Promotional Offer.
5. Use of the Promotional Offer constitutes acceptance of these Regulations.
6. The following top-up variants are available as a part of the Promotional Offer:

7. The conditions of using the Promotional Offer are as follows:
  - a) having an Internet User Account at [www.mobilevikings.pl](http://www.mobilevikings.pl) or using our Mobile App.
  - b) having an active SIM card in the „Mobile Internet” tariff.
8. In order to make use of the Promotional Offer one should do the following:
  - a) after logging into the User’s account via [www.mobilevikings.pl](http://www.mobilevikings.pl), or through our Mobile App, choose a top-up, with a chosen package variant, of your liking.
  - b) perform a top-up, with the chosen variant, by paying for it with one of three available payment methods.
9. A person that would like to make use of the Promotional Offer, but isn’t a Mobile Vikings User, should first place an order for a new SIM card, by following these steps:
  - a) go to [www.mobilevikings.pl](http://www.mobilevikings.pl)
  - b) choose a top-up variant
  - c) input your data and SIM card shipping address
  - d) pay for the order
  - e) activate your SIM card.
10. If a top-up of the SIM card occurs during the period of validity of the previously purchased Top-up, the basic data package shall accumulate. The validity period of the totalized Internet package shall be prolonged by the number of days stated in Table no.1 or Table no. 2 for a specific Top-up, counting from the day of the Top-up’s realisation.
11. Performing a Top-up results in the prolongation of the SIM card’s validity period by 365 days, counting from the moment of the Top-up’s realisation.
12. There is no limit of how much basic data package you can have.
13. The worth and the validity period of the Internet package can be checked, each time, after logging into your User account at [www.mobilevikings.pl/pl/mysims/](http://www.mobilevikings.pl/pl/mysims/) or through the Mobile App provided by the Operator.
14. The provision of the Promotional Offer services begins upon the Top-up’s realization.

15. Only one Top-up from the Viking Net or Viking Net&Night option may be activated, as shown in points 8-9. However, as part of the Promotional Offer, the User may purchase any number of Top-ups in different variants.
16. There is no possibility of deactivating a Top-up after the activation of the SIM card and during the validity period of the package.
17. The User shall receive a possibility to make use of the Top-up within 24 hours from performing the actions presented in points 8-9 of these Regulations.
18. Use of the package is only possible within the territory of the Republic of Poland with the use of the Operator's APN Internet settings. The Promotional Offer won't be active within international roaming.
19. Until the data transfer limit is met, the Subscriber may download files with a maximum speed of up to 300 Mb/s. Certain factors such as: the technology in which the data is transmitted, current level of traffic on the transmitter, strength of the received signal from the transmitter, maximum speed supported by the device as well as weather conditions may influence the actual speed of data transmission. Along with the progress of technology, the upper speed limit may be raised up.
20. In case the User uses up the available data package, or its validity period ends, the Operator reserves the right to reduce the speed of data transmission to 0 kbit/s. Maximum speed shall be restored upon the purchase of a new Top-up.
21. Subscribers using the Viking Net & Night top-up variant may use the data transmission within the territory of the Republic of Poland and via P4 Telecommunications Network, between 23:45-08:45 without reducing their available data package.
22. A Subscriber, that uses up the data transmission limit from the basic data package, will not be able to make use of the service within this period – the same is true for the Viking Najt night package service. In order to restore the ability to connect to the Internet, one needs to perform a Top-up using one of the top-up variants.

### **§ 3. ADDITIONAL INFORMATION**

23. All prices presented in these regulations are in Polish zloty (PLN) and include VAT, unless otherwise specified.
24. The use of the Promotional Offer does not exclude the use of other Promotional Offers offered by Mobile Vikings Poland, unless the Regulations of those Offers provide otherwise.
25. In matters not regulated hereby, the provisions of the Price List of Mobile Vikings Offer and the Regulations for the Telecommunications Services provision shall apply.
26. In case of discrepancies between the provisions hereof and the provisions of the aforementioned documents, the provisions of the Regulations of this Promotional Offer shall prevail.
27. All words and phrases capitalized herein shall be construed in accordance with their definitions provided for in the Price List or the Regulations for the Telecommunications Services provision.
28. The Operator reserves the right to amend or recant the Regulations at any time without giving any reason, provided that the amendment or recantation of the Regulations does not affect the rights and obligations previously acquired by the Subscriber.
