

§ 1. GENERAL CONDITIONS OF THE USE OF PROMOTIONAL OFFER

1. The Promoter of the „Pack your things and go to Mobile Vikings” (hereinafter referred to as the „Promotional Offer”) is VikingCo Poland sp. z o.o. with its registered office at: ul. Tęczowa 13/210, 53-601 Wrocław, entered into the Register of Entrepreneurs of the National Court Register, KRS registration number 0000484436, kept by the District Court for Wrocław Fabryczna, 6th Commercial Division of the National Court Register, NIP [tax identification number] 8971793639 and REGON [national business registry number] 022284492, hereinafter referred to as the „Operator”.
2. This Promotional Offer is aimed at the Subscribers of Mobile Vikings Poland, who are using the „Minutes+SMS+Internet” offer, and perform a transfer of their number from a Postpaid or Prepaid service, from a Donor operator to the Mobile Vikings Network, while this Promotional offer lasts.
3. Using this Promotional Offer means the acceptance of the contents of these regulations.

§ 2. SUBJECT-MATTER OF THE PROMOTION

4. As a part of the Promotional Offer, the Subscribers, who have fulfilled the condition mentioned in point no. 2, shall receive upon the, scheduled by the Donor operator, date of the transfer, a one-time package of additional 10GB of mobile data, valid for 31 days (hereinafter referred to as the „Promotional Package”), for each number transferred to Mobile Vikings during the promotional period.
5. In order to fulfill the condition from point no. 2, one needs to properly file a porting request from the Donor operator to the Mobile Vikings network, which is then accepted by the Donor operator, and transfer the number on the date pointed in the porting request. The Promotional Offer is in effect for a Subscriber, who has filed a porting request during the course of the Promotional Offer.
6. If the porting request is declined by the Donor operator or the Subscriber cancels the transfer process on his own, the Promotional Package will not be granted.
7. The Promotional Package, together with the chosen Top-up, shall be automatically activated upon the date of the transfer and will be added to the Internet data package, available on this day, on the Subscriber’s balance, and its validity period will be equal to 31 days counting from the activation of the number. If the next top-up or the Internet package purchased with available calling credit, will be done during the validity period of the Promotional Package, the remaining amount of GBs will be added, and the validity period will be extended by the number of days from the chosen offer, counting from the day of the top-up or the purchase of an additional Internet data package.

8. The amount and validity period of the Internet package can be checked, each time, by logging into the User's Internet account on our website at www.mobilevikings.pl/pl/mysims, by inputting the *108# USSD short code on your Phone or on the Mobile App distributed by the Operator.
9. Activation of the Promotional Package does not extend the Validity period of outgoing calls, SMS/MMS package and unlimited calls package.
10. The Subscriber cannot order the deactivation of the granted Promotional Package, what is more he cannot change the activation date of this package neither can he transfer it to another number within his User's Internet account.
11. The Promotional Package shall be automatically deactivated when its validity period ends, if it is not renewed, by making a new Top-up or the purchase of an additional Internet data package.
12. Use of the Promotional Package is only possible, in the territory of the Republic of Poland, within the Operator's offered signal range with the use of the Operator's APN Internet settings. This Promotion does not work within international roaming.

§ 3. ADDITIONAL INFORMATION

13. As a part of this Promotional Offer, the Subscriber is obliged to adhere to the Regulations for the Telecommunications Services provision.
14. In the event of the violation of these regulations or the Regulations for the Telecommunications Services provision, the Operator may suspend the provision of the Services.
15. Using of this Promotional Offer does not exclude the possibility of using other Promotional Offers offered by the Operator, as long as the Regulations of these Offers do not provide otherwise.
16. To all matters not settled in these Regulations, the provisions of the Mobile Vikings Poland Price List and the Regulations for the Telecommunications Services provision, shall apply. In the event of discrepancies between the provisions of these regulations and the aforementioned documents, provisions of this Promotional Offer will have precedence.
17. The definitions used in this Offer (specifically those written with capital letters) are to understood according to the definitions included in the Price List or the Regulations for the Telecommunications Services provision.
18. Regulations for the Telecommunications Services provision, Price List as well as the remaining documents regulating the provision of the services by the Operator are published and made available on the website of the Operator at: www.mobilevikings.pl
