

§ 1. GENERAL CONDITIONS OF THE USE OF THE PROMOTIONAL OFFER

1. The Promoter of the „Number registration bonus”, hereinafter referred to as the Promotional Offer, is VikingCo Poland sp. z o.o. with its registered office and address in: Ul Tęczowa 13/210, 53-601 Wrocław, entered into the Register of Entrepreneurs of the National Court Register, KRS registration number 0000484436, kept by the District Court for Wrocław Fabryczna, 6th Commercial Division of the National Court Register, NIP [tax identification number] 8971793639 and REGON [national business registry number] 022284492, hereinafter referred to as the Operator.
2. This Promotional Offer is aimed at future and current Users of the Mobile Vikings Network, that are using the „Minutes+SMS+Internet” tariff or the „Mobile Internet” tariff in the Mobile Vikings network, and have fulfilled the conditions mentioned in these Regulations.

§ 2. DETAILED CONDITIONS OF THE USE OF THE PROMOTIONAL OFFER

3. As a part of the Promotional offer, the Subscriber (depending on his/her tariff) gets the following bonuses for the number taking part in the promotion:
 - a) for the ‘Minutes+SMS+Internet’ tariff:
 - **10 GB** valid for **31 days**
 - **unlimited voice calling to all national cellular and landline networks package for 31 days**
 - b) for the ‘Mobile Internet’ tariff:
 - **14 GB** valid for **60 days**hereinafter referred to as the „Bonus” zwane dalej „Bonusem” based on the rules described in these regulations.
4. The condition for receiving the Bonuses, described in point 3, is:
 - a) The deposition of personal data at Mobile Vikings network and registration of one’s number in a way shown on the Operator’s website.
 - b) One needs to have an active number at the moment of the Bonus’ activation
 - c) One needs to have, on the registered number, a paid and realized top-up for a minimum of 10PLN for the Users of the „Minutes+SMS+Internet” tariff, and a top-up for minimum 20 PLN for Users of the „Mobile Internet” tariff
 - d) If point c) was not met before the Number registration process, in order to get the bonus, a top-up for a minimum of 10 PLN (for the Users of the „Minutes+SMS+Internet tariff), and a

minimum of 20 PLN (for the Users of the „Mobile Internet” tariff) need to be made during the duration of the Promotional Offer.

- e) The activation of the Bonus as described in point 7.
5. The activation of the Bonus and the use of the Promotional Offer is free.
6. Details of the Bonuses:
 - a) for the 'Minutes+SMS+Internet' tariff:
 - **a package of 10 GB valid for 31 days**, which can be used for data transfer on the territory of the Republic of Poland as a part of the offered by the Operator reception, with the use of the Operator's APN Internet settings. The activation of the 10GB Bonus, while the data package is still valid, prolongs its validity period by 31 days counting from the day of its activation. If the next top-up, or the purchase of additional internet data pack from the available calling credit, occurs during the validity period of the Bonus, the data packages shall add up, and the validity period shall be prolonged by a number of days from the chosen offer, counting from the day of the top-up's realization or the purchase of an additional data pack.
After the data package is used up or its validity period ends and it won't be renewed, data transfer shall be charged in accordance with the Offer's Price List, that the User is currently using. The Bonus of 10GB of data package is valid for 31 days counting from the day of its activation.
 - **unlimited voice calling to all national cellular and landline networks package for 31 days**, which can be used to make voice calls to each national cellular and landline operator, realized using the Telecommunications network, with the exception of Premium numbers, helplines and audiotext numbers listed in the Price List.
The Bonus is valid for 31 days, counting from its activation. In an event such a package is already active, the validity periods will not add up.
 - b) for the 'Mobile Internet' tariff:
 - **a package of 14 GB valid for 60 days**, which (after its activation) shall be seen as the Viking Net top-up for 30 PLN, the package can be used for data transfer on the territory of the Republic of Poland as a part of the offered by the Operator reception, with the use of the Operator's APN Internet settings. The activation of the 14GB Bonus, while the data package is still valid, prolongs its validity period by 60 days counting from the day of its activation. If the next top-up occurs during the validity period, the data packages shall add up, and the validity period shall be prolonged by a number of days from the chosen offer, counting from the day of the top-up's realization.
After the data package is used up or its validity period ends and it won't be renewed, it won't be possible to connect with the Internet. The 14GB Bonus is valid for 60 days counting from the day of its activation.

§ 3. THE ACTIVATION AND THE USE OF THE SERVICE

7. In order to activate the Promotional Offer, the following steps need to be done:
 - a) log into the Mobilve Vikings Internet User account
 - b) go to the „My cards” bookmark, and activate the Bonus, on the chosen number, by clicking the button with the preferred Bonus.

8. The Bonus is activated within 24 hours from performing the actions listed in point no. 7.
9. The activation of the Bonus is possible only during the period of the Promotional Offer's duration, at the latest up to the 1st February 2017. In case of Subscribers, who have applied a porting request before 1st of February, and the donor operator has accepted such a request at the latest to this date, and where the date of the porting has been set after 2nd of February 2017 inclusive, the activation of the Bonus will be possible until 30th June 2017. After this date, the button to activate the Bonus shall be deactivated (and later on removed).
10. The state of the Bonuses can be each time checked on the Internet User account or through the mobile application VikingApp Poland.
11. Each number can make use of the Promotional Offer only once.
12. From the Promotion are excluded numbers, for which the Operator provides special services based on business agreement.
13. Once activated, the Bonus cannot be deactivated during its validity period.
14. The use of the service does not exclude the possibility of the use of other Promotional Offers available together with the offer, that the User is using, unless the conditions of other Promotional Offers state otherwise.
15. The User may download files with the maximum speed specified for this Service. If the User makes use of transmitters owned by Play, the maximum achieved speed of data transfer will be up to 70Mb/s. In national roaming the maximum data transfer speed will be up to 30Mb/s and is based on the rules and conditions of agreements between the operators and technical parameters that influence the network's configuration. The actual speed of data transfer is based on the following parameters: the strength of the transmitter's signal, the current load on the transmitter and the technology of data transfer: EDGE, HSPA, HSPA+, 3G, 4G LTE.
16. In an event of using up all of the data from the data package, by the User, during the validity period of the Package activated as a part of the Bonus, the Operator reserves the right to limit the speed of data transfer up to 32kb/s. The maximum speed shall be restored after the next top-up's realization or the purchase of an additional Internet data pack.

§ 4. ADDITIONAL INFORMATION

17. All prices indicated in these Regulations are in Polish zloty (PLN) and include VAT, unless otherwise specified.
18. Under this Promotional Offer the User shall:
 - a) not direct traffic from other telecommunication networks without the consent of the Telecommunications Network Operator or networks of other telecommunications companies by means of any telecommunication devices using the SIM/USIM Cards received by the User
 - b) not to use, without the consent of the Operator, any devices that allow access to the Telecommunication Network or the realization of connections with the use of the user's device intended for connecting with landline network or any other device acting as such, in which SIM/USIM cards, working in the Telecommunication, are used.
 - c) not to generate artificial traffic for the exchange of information
 - d) not to use SIM/USIM card for telemetry
 - e) not to use the SIM/USIM Card for the traffic generated by machine, in particular "machine-to-machine" and "machine-to-user" traffic type
 - f) not use the SIM Card to generate traffic, which is a Denial of Service attack

- g) not to use the SIM/USIM cards without the consent of the Operator, to initiate the traffic involving the mass calls making, particularly in the case of automatic calls distribution or automatic interactive called number service, or in the case of telecommunication and information systems integration for this type of traffic or when using the cards in direct marketing (the prohibition applies to the User acting as an entrepreneur or on behalf of another entrepreneur)
 - h) not use the SIM/USIM Card for the mass mailing of information (SMS or MMS) intended directly or indirectly to promote goods, services or image of the User or another entity, or in some other way of achieving any commercial effects (the prohibition applies to the User acting as an entrepreneur or on behalf of another entrepreneur).
19. In the event of a breach of the provisions laid down in Section 17 points a. to h. of this Promotional Offer by the User, the Operator may suspend the provision of Services.
 20. In matters not regulated hereby, the provisions of the Mobile Vikings Polska Offer Price List and the Regulations of the Telecommunications Services shall apply.
 21. In case of discrepancies between the provisions hereof and the provisions of the aforementioned documents, the provisions of the Regulations of this service shall prevail.
 22. All words and phrases capitalized herein shall be construed in accordance with their definitions provided for in the Price List or the Telecommunications Services Regulations.
 23. In matters not covered hereby the provisions of the documents specified in point 20 shall apply.
 24. The Operator reserves the right to amend the Regulations, or to cancel them at any time without giving any reason, provided that that amendment or cancellation of the Regulations does not affect the rights and obligations previously acquired by the User.
