



# 3x3 SWISS TOUR 2026

I herewith acknowledge and agree that:

1. I am bound to and shall comply with Swiss Basketball regulations (e.g. Statutes, Disciplinary Rules (Règlement juridique), etc ), to the extent applicable, and specific 3x3 regulations/guidelines issued by Swiss Basketball (in particular the 3x3 Swiss Tour's Handbook) and/or FIBA (in particular FIBA 3x3 Official 3x3 Basketball Rules) (together the "Regulations"), as in force and published at the time of the Competition, and with any decisions issued by Swiss Basketball and its bodies, in particular its judicial bodies which I accept having competence to decide on the consequences of any violation I commit, and divisions (jointly "Swiss Basketball") based on the Regulations. My participation in the Competitions is conditional upon my valid acceptance of and compliance with each and every provision of this Entry Form. I am aware that violating the Entry Form may harm other players, including my teammates (e.g. a sanction may affect the entire team).
2. I shall respect (and have respected during the 3x3 Season) the spirit of fair play, clean game and non-violence in any discipline governed by Swiss Basketball and I shall behave (and have behaved during the 3x3 Season) accordingly on and off the court.
3. If I violate clause 1. or 2. above, Swiss Basketball may sanction me not only in accordance with the Regulations (in particular the Disciplinary Regulations), but also exclude me from the Competitions and/or refer the case to FIBA to provisionally or permanently exclude me from [play.fiba3x3.com](http://play.fiba3x3.com) depending on the seriousness of the violation. In addition, Swiss Basketball may decide whether any game in which the violation occurred shall be forfeited and whether I (personally or along with my team) shall be banned from further participation in the Competition in which the violation occurred. The decisions rendered on the spot by Swiss Basketball with regard to a specific stage of the Swiss Tour are final and not subject to appeal.
4. I shall comply with Swiss Olympic, Antidoping Swiss, Swiss Basketball and FIBA anti-doping rules, as may be amended from time to time, and I shall be subject to the jurisdiction and sanctioning power of the bodies referred to therein.
5. I participate in the Competitions at my own risk and I will take all reasonable measures to protect myself against the risks of participation. I am responsible for all property I bring into the Competitions. I am responsible for obtaining medical and general liability insurance (if any) covering my participation in the Competitions; neither Swiss Basketball, nor the other organizer, if any, of the Competitions will contract any such insurance for me.
6. To the extent permitted by law, Swiss Basketball (and its respective members, directors, officers, employees, volunteers, sponsors, contractors or agents) shall not be liable for any loss, injury or damage that I may suffer in relation to my participation in the Competitions.
7. In consideration of the acceptance of my participation in the Competitions and of the benefits linked thereto,
  - I agree to be filmed, televised, photographed, identified and otherwise recorded at the Competitions. I acknowledge Swiss Basketball's right to use such material in a similar way as detailed in the Terms and Conditions of [play.fiba3x3.com](http://play.fiba3x3.com) to which I herewith agree; this includes potential use of my name, likeness, autograph and other identifying characteristics in e-games.
  - I shall respect the Official Gear policy enshrined in the 3x3 Swiss Tour's Handbook.
8. This Entry Form shall be valid from the date of signature until the end of the tour.
9. I agree that this Entry Form and any obligations and disputes arising out of or in connection with it shall be governed by and construed pursuant to Swiss law without its conflict of laws rules. I agree that any dispute, controversy or claim arising out of or in connection with this Entry Form, the Competitions and/or any other shall be submitted exclusively to the Court of Arbitration for Sport (CAS) and resolved definitively in accordance with the Code of sports-related arbitration. The arbitration shall be governed by Chapter 12 of the Swiss Act on Private International Law (if I am domiciled in Switzerland, I waive the application of the third part of the Swiss Code of Civil Procedure). The seat of the arbitration shall be in Lausanne, Switzerland. The language of the arbitration shall be English. I shall not and I hereby waive my right to institute any claim, arbitration or litigation, or seek any other form of relief, including provisional measures, in any other court or tribunal.
