PRIVACY STATEMENT FOR THE TREATMENT OF PERSONAL DATA BY SWISS BASKETBALL

Version: 12 September 2020

The purpose of these regulations is to **guarantee your privacy**.

In this document, Swiss Basketball explains the extent to which it processes personal data in connection with the use of the applications Swiss Basketball App (Swish), Leverade, InGame, and his partners Tech 4 Teams SAS, Ticketmaster Schweiz AG, Smeetz SA, and more generally, all personal data that are processed by Swiss Basketball.

This is not an exhaustive description; some specific elements can be addressed in additional privacy statements, similar documents, conditions of use or application programs.

Data protection legislation regulates the processing of personal data. The Swiss Federal data protection legislation and, when applicable, European data protection law, applies to data processing.

Personal data is defined as all information relating to a person identified or identifiable. Processing shall mean any operation relating to data whatever the means and processes used - including the collection, processing and use of personal data - and the retention, use, modification, disclosure, archiving or destruction of data.

1. CONTROLLER

2. PERSONAL DATA AND PURPOSES OF PROCESSING

Swiss Basketball maintains a database ("The Swiss Basketball Data Base") that contains:

- for **players**: the first name, last name, gender, address of domicile, date of birth, email address, telephone number, nationality, player's license number, photo, bib, ID or passport number, a copy of the passport or identification card, player height, player's field position, the club to which the member is licensed, the licence number and videotaping of certain games ("the Swiss Basketball Registry Database").
- For **coaches and referees**: the first name, last name, gender, address of domicile, date of birth, email address, telephone number, nationality, player's license number, photo, bib, ID or passport number, a copy of the passport or identification card, the licence number and videotaping of certain games, video recording of certain games and bank account number.

- For **club members**: name, telephone number, e-mail, name of the venue, direction, Postal Code, municipality, province (Canton), CIF (or your tax number), Bank account number, name of the president, foundation year, country, social networks (twitter and facebook) and date of constitution.
- For **clients**: first name, last name, gender, address of domicile, date of birth, email address, telephone number for the purposes of ticketing, cashless, online shop and access control to sport events organised by Swiss Basketball.

The purposes of the Swiss Basketball Database are the organisation and promotion of basketball competitions in Switzerland and advertising purposes to the exclusive Swiss Basketball's commercial partner companies ("Sponsors").

Your entry in the Swiss Basketball Registry Database is also necessary for the use of the electronic match sheet. Your data will also be recorded for communication through the Digital Communication Platforms and on the website www.swissbasketball.ch.

3. COMMUNICATION OF DATA

Name, first name, date of birth, photo, bib and video recording of certain games will be accessible through web access and mobile application download, together with the registration of the minutes and statistics of the match, allowing public access to these contents to third party who is a user of the indicated media and communication platforms, both live during the competition, and after its conclusion, with the possibility of carrying out the **compilation of statistics, reproduction of games** or specific plays, count of baskets, incidents, sanctions and other **analyses related to the competition** or game(s) held, including the combination of all this data with extracts or sequences of the audio-visual material it contains the recording of the competition or match(s).

To the exception of these data, **no third party** to the exception of Swiss Basketball and its processors **will have access to these data** unless you authorised us to communicate certain personal data to our sponsors (optional). In addition, the Regional Association to which you club belongs will also have access to your profile in order to verify the accuracy of the data that you have provided to Swiss Basketball.

SWBA's processors are contractually obliged to comply with the requirements of Swiss or European law on data protection. They have contractually no right to use for personal purposes secondary data generated during the course of the execution of the contract.

4. DATA SECURITY

In order to protect data against unauthorized access, loss or misuse, Swiss Basketball, in close collaboration with its internal and external hosting providers and with other IT service providers, takes adequate security measures of a technical nature (e.g., encryption, pseudonymization, history, access controls, access limitations, security of data, IT and network security solutions, etc.), and of organizational

nature (e.g., employee guidelines, confidentiality agreements, controls, etc.) in accordance with the requirements of the Swiss and EU legislation in data protection matters.

5. YOUR RIGHTS

1. To comply with these regulations, you need to **give consent** to collection and storage of the personal data we indicated above before data can be shared with Swiss Basketball partners. If you are giving **consent on behalf of a child in your care**, please explain to the child as much as they can understand.
2. **If you do not consent to the processing of your data for the purposes of competitions and adherence to the Swiss Basketball rules (boxes mentioned as mandatory when registering on the Leverade platform), you will not be able to participate in the competitions** since your registration is mandatory in particular for the use of the electronic match sheet which will be used for certain competitions. Consent to the processing of data for marketing purposes is, however, optional and its non-selection during the registration process does not prevent you from participating in the competitions.
3. Your personal data will be processed as long as the audio-visual material of the matches and tournaments is still published. In any case, all the personal data contained in this authorization will be kept for the periods established in the applicable regulations for the requirement of compliance with legal obligations and responsibilities.
4. You have the **right to access, modify/oppose, correct** and **delete data** concerning you. To exercise this right, you must send us a request by e-mail accompanied by a photocopy of your identity card or passport to the following address: dataprotection@swissbasketball.ch.

6. PROCESSOR

One of the processors of Swiss Basketball is Nothingbutnet, S.L., a company that has its registered address at C/ Juan de la Cierva, 27 Edificio Wellness 1 46980 Paterna (Valencia), Spain. Its dedicated email address for questions on data protection is dpd@nbn23.com NBN23 and its authorized subcontractors, among which Mileyenda Entertainment S.L. which operates the Leverade platform, are data processors under data protection law. They will have access to the data on behalf of Swiss Basketball for the provision of services related to the publication and hosting of the data in the authorized media and communication platforms and other auxiliary services as well as statistical studies and analyses after having signed a treatment order contract with sufficient security guarantees and the obligation to anonymize information at the end of their mission, keeping only disaggregated and aggregated data. No data processor is authorized to communicate any personal data without the prior written consent of Swiss Basketball.

Legal basis and purposes of treatment: With legal basis in the consent granted by signing this document, the Personal Data will be processed for publication and dissemination in the media and communication platforms indicated in this document along with the material audiovisual of the match or tournament in which the you or Minor participate, with the possibility of carrying out the analysis and statistics, reproduction of the match or specific plays, basket counting, incidents, sanctions and other analyzes

related to the match or tournament, including the combination of this data with excerpts or sequences of audiovisual material containing the recording of the match or tournament. In case of persona data of a Minor, with legal basis in compliance with legal obligations, the personal data of the parent/guardian/legal representative of the Minor, will be processed to prove the scope of this authorization and compliance with current regulations on data protection in front of third parties.

Recipients of the personal data: With legal basis in the consent granted by signing this document, the your Personal Data or/ such of the Minor will be published through the media and communication platforms authorized at the beginning of this document, being accessible by any third party with Internet access. With legal basis in the fulfillment of legal obligations, the data of the Minor as well as that of his/her parent/guardian/legal representative, may be communicated to the competent public Administrations by reason of the matter, courts and tribunals.

In addition, NBN23 and other third parties (all of them data processor) will have access to the data on behalf of Swiss Basketball for the provision of services related to the publication and hosting of the data in the authorized media and communication platforms and other auxiliary services as well as statistical studies and analyzes. after signing a treatment order contract with sufficient security guarantees and the obligation to anonymize the information at the end of the order, keeping only disaggregated and aggregated data.

International transfers: the data will not be subject to international transfer although its publication through the internet constitutes a universal treatment.

Data retention period: The publication of your Personal Data or such of the Minor will be treated through the means and communication platforms indicated in this authorization as long as the audiovisual material of the matches and tournaments is still published. In any case, all the personal data contained in this authorization will be kept for the periods established in the applicable regulations for the requirement of compliance with legal obligations and responsibilities.

Exercise of rights: The interested party may exercise, both in their own name and in their case on behalf of the Minor, their rights of access, rectification, deletion, limitation to treatment, opposition, portability and not be the subject of a decision based exclusively in the automated processing of your personal data as well as revoking the consent provided in this document without such revocation being retroactive by sending a request to Swiss Basketball indicating the right that it exercises and providing a photocopy of both sides of the ID or legal document of identification of the identity as well as, where appropriate, of the person holding the representation, together with the document proving such representation. The request can be sent to the address mentioned at the beginning of this Privacy Statement.

Likewise, the interested person is informed of the right to file a claim with the Spanish Agency for Data Protection C/Jorge Juan, 6, 28001 Madrid, +34 901 100 099 - +34 912 663 517 (www.agpd.es) in particular, when they consider that they have not obtained satisfaction from Swiss Basketball in the exercise of their rights or the guarantees in the treatment of their data have been violated. Prior to any claim and on a voluntary basis, the interested person may contact the data protection officer of Swiss Basketball Federation through the following email address: (dataprotection@swissbasketball.ch).

6. AMENDMENTS

Swiss Basketball may adapt this privacy statement at any time without prior notice. The current published version and the version valid for the period concerned shall apply. This confidentiality statement has been drawn up in several languages. The French version is authoritative in case of differences. In the event of an update, the users of the application are informed of the changes in an appropriate manner.
