Within our Company's current registered capital ceiling of TRY 50,000,000,000, the increase of the paid-in capital from TRY 10,000,000,000 to TRY 20,000,000,000 through a 100% bonus issue amounting to TRY 10,000,000,000, to be covered from dividend, and the amendment of Article 7 of the Company's Articles of Association have been approved by the Capital Markets Board of Türkiye (CMB). The announcement regarding the approval of the share issuance by the CMB was published in the CMB Bulletin No. 2026/36 dated June 10, 2026. Approved Issue Document and Articles of Association Amendment are attached.

The rights to acquire bonus shares starts on 15.06.2026.
