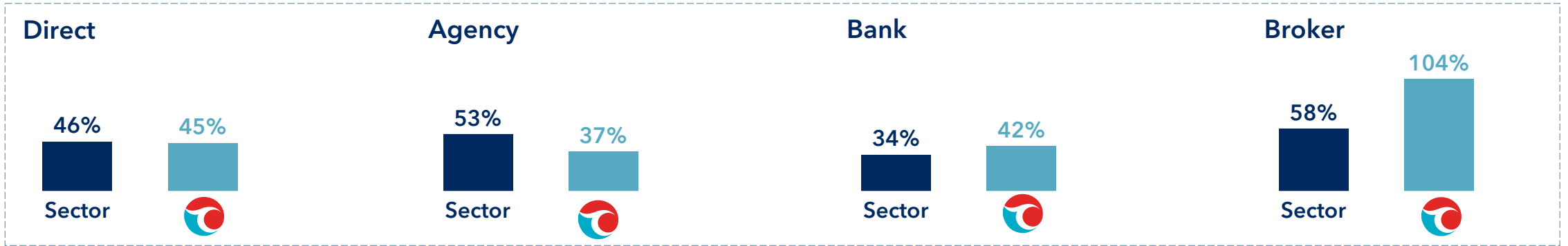

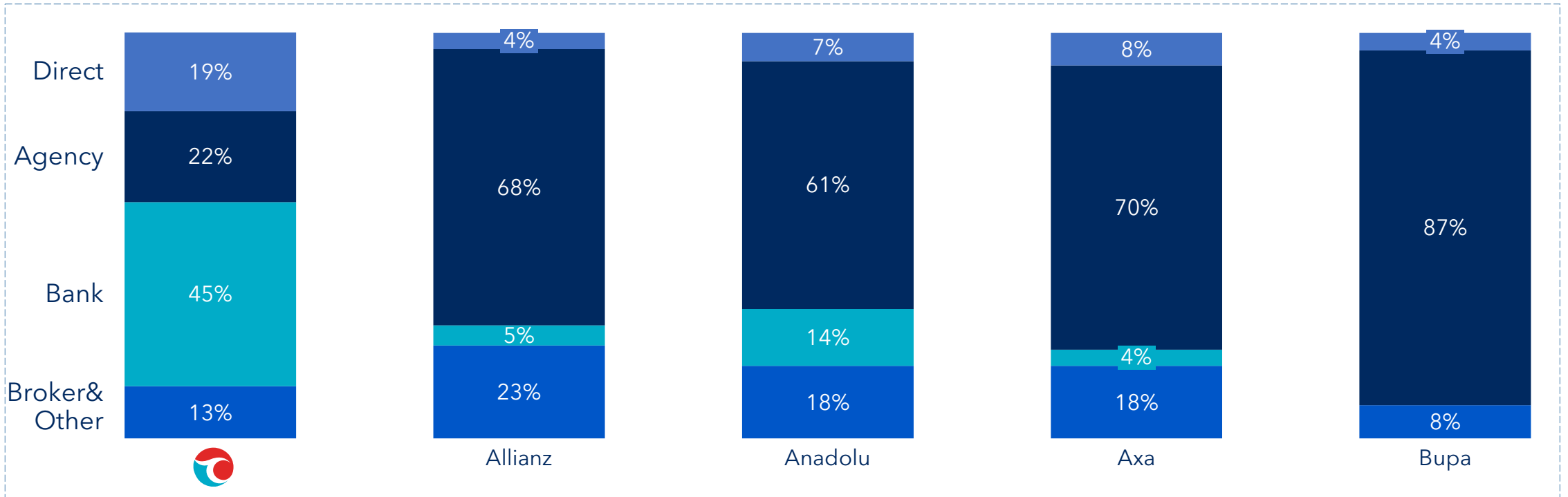


# Distribution Channel
