

Rules of the "Competition for tickets to the White Night Festival 2023"

- 1. Organizer of the Competition: The organizer of the "Competition for tickets to the White Night Festival 2023" (hereinafter referred to as the "Competition") is the company International Visegrad Fund, with its registered office at Hviezdoslavovo nám. 9, 811 02 Bratislava, ID number: 36060356.
- 2. Place and duration of the competition: The competition takes place on the Instagram profile https://www.instagram.com/visegradfund/ and the Facebook profile https://www.facebook.com/visegradfund/

The competition will take place from Sep 25, 2023, at 12 noon to Sep 27, 2023, at 12 noon.

- 3. Contest Participants: For the purposes of these Rules, a Contest Participant is a natural person with a permanent residence or temporary residence in the territory of the Slovak Republic, who has reached the age of 18 on the day of the contest launch and who fulfills the conditions for participation in the Contest according to the Rules (hereinafter referred to as "Competition Participant"). An employee of the International Visegrad Fund, as well as cooperating persons participating in the organization of this Competition, including their employees, cannot participate in the competition.
- 4. Entry into the Competition: A Participant of the Competition will be entered into the draw according to the Rules, who during the duration of the Competition from 9/25/2023 from 12 p.m. by 9/27/2023 by 12:00 p.m. fulfill the conditions stated in the competition Instagram and Facebook post. By participating in the competition, the participant agrees to these Rules. The organizer will draw 2 winners on Facebook and 2 winners on Instagram.
- 5. Drawing: The organizer will draw after the end of the Competition on 27.9. 2023 of all Contest Entrants who meet the Rules, 2 winners on Facebook and 2 winners on Instagram. The draw will take place at the Organizer's random selection from all Contest Participants who have met the Contest conditions. The draw will take place with the participation of the Organizer's representatives.
- 6. Prize: The organizer will give the winners the prize tickets to the contemporary art festival White Night, which takes place in Bratislava from Sep 29, 2023 to Oct 1, 2023. The organizer bears no responsibility for defects in the prize and the prize is not covered by a quality guarantee.



- 7. Notification of the prize: Winners will be notified in a comment on the Facebook and Instagram competition postdated Sep 25, 2023 and will be invited to contact the organizer via a private Instagram or Facebook message, where the organizer and the winners will agree on the procedure for handing over the prize. In the event that the winners cannot be contacted within 2 days (48 hours) or the winner does not express interest in acquiring the prize, gives up the prize or refuses the prize, the right to the prize expires.
- 8. Realization and receipt of the prize: The prize will be handed over electronically, by sending the tickets to the winner's e-mail address.
- 9. Personal data: Processing of personal data of Contest Participants, or the winner, as affected persons, is governed by the Regulation of the European Parliament and the Council (EU) no. 2016/679 on the protection of natural persons in the processing of personal data and on the free movement of such data (hereinafter referred to as "GDPR"), and Act No. 18/2018 Coll. on the protection of personal data in the effective version. The operator of the processing of personal data is the Organizer – the International Visegrad Fund, with its registered office at Hviezdoslavovo nám. 9, 811 02 Bratislava, ID: 36 0603 56. For the purpose of carrying out and evaluating the Competition, the Organizer processes the name, surname, address of permanent residence, zip code, e-mail address and telephone number. In the event of a win, the Organizer uses the contact details of the winner to announce the win. For the purpose of handing over the prize, the Organizer will also process other identification data of the winner. The winner's data is also stored for tax administration purposes in accordance with legal regulations (Act No. 563/2009 Coll. on Tax Administration (Tax Code) and on Amendments to Certain Acts, Act No. 595/2003 Coll. on Income Tax) and may be used in the event of the need to apply, defend and prove the Organizer's legal claims (e.g. in the case of a supervisory authority or a court case).

The winner will be published on the Organizer's website by indicating the name and the initial letter of the last name. In case of failure to provide any of the mentioned data, it will not be possible to participate in the Competition or receive any winnings.
